FOURTH MONTH, APRIL- FOURTH STEP

The Importance of Step 4 in the 12 Steps of AA

The purpose of Step 4

Making a searching and fearless moral inventory of yourself.

This is the beginning step in determining the root cause of one's drinking, identifying any weaknesses that may have contributed to alcoholism, and understanding personal strengths that can help support the person with their self-discovery and recovery in AA. Through this moral inventory, the alcoholic will uncover negative thoughts, emotions, and actions that have contributed to the spiraling of their addiction. They will also direct their attention from blaming others to seeing their part in problems created. This step requires humility and rigorous honesty, as being truthful with oneself will be the blueprint for success with sobriety.

I'm slowly learning that even if I react, it won't change anything, it won't make people suddenly love and respect me, it won't magically change their minds. Sometimes it's better to just let things be, let people go, don't fight for closure, don't ask for explanations, don't chase answers and don't expect people to understand where you're coming from. I'm slowly learning that life is better lived when you don't center it on what's happening around you and center it on what's happening inside you instead. Work on yourself and your inner peace

In Case of Errors or Questions About Your Electronic Transfers, Statement, or Bill and Your Rights

If you think your statement or bill is wrong, or if you need more information about a transaction on your statement or bill, write us on a separate sheet of paper at P.O. Box 2469, Pocatello, ID 83206. We must hear from you no later than 60 days after we sent you the FIRST statement or bill on which the error or problem appeared. You can call us at 1-800-456-5067, but doing so will not preserve your rights. In your letter, give us the following information:

- Your name and account number.
- The dollar amount of the suspected error.
- Describe the error and explain, if you can, why you believe there is an error. If you need more information, describe the item in question.

We will investigate your complaint and will credit any error promptly. If we take more than 10 business days to do this, we will credit your account for the amount you think is in error, so you will have the use of the money during the time it takes us to complete our investigation. You do not have to pay any amount in question while we are investigating, but you are still obligated to pay the parts of your statement or bill that are not in question. While we investigate your question, we cannot report you as delinquent, or take any action to collect the amount in question.

Special Rule for Visa Card Purchases

If you have a problem with the quality of goods or services you purchased with a Visa card, and you have tried in good faith to correct the problem with the merchant, you may not have to pay the remaining amount due on the goods or services. You will have this protection only when

the purchase price was more than \$50 and the purchase was made in your home state or within 100 miles of your mailing address. (If we own or operate the merchant, or if we mailed you the advertisement for the property or services, all purchases are covered regardless of amount or location of purchase.)

What if I needed an A.A. meeting and there was none?

There are over 35,000 A.A.s in confinement and over 1,400 prison groups throughout the United States and Canada. These meetings answer only a fraction of the need for more groups in correctional facilities all across the country. Many there reach for, but don't find, the hand of A.A.

Carrying the Message Into Correctional Facilities-AA approved literature

Treatment Centers:

- Currently, TV TAC helps at least 140 alcoholics in treatment centers by supporting 19 AA meetings per week across 6 facilities.
- There are 4 more facilities we want to open but **need 30+ volunteers** to make this happen.

Accessibilities:

- This services people who cannot get to meetings or have language/other unique needs.
- We **need 15 volunteers** who can go onsite or online to hold meetings with individuals.

Corrections Facilities:

- Currently, TV TAC helps at least 70 alcoholics in correction facilities by supporting meetings in 4 prisons (2M/2F) and 2 jails (1M/2F).
- There are an additional 5 prisons, 5 reentry centers and 2 local jails with 10,000 inmates that we want to support but **need 20 men and 20 women volunteers** to make this happen.

Bridging the Gap:

- Help bridge the gap between prison/jail and building a life in recovery by taking newly released people to three (3) AA meetings. We **need 10 men and 10 women volunteers!**

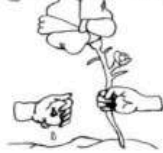
