Acceptance vs. Allowance: The Quiet Tug-of-War

At first glance, “acceptance” and “allowance” sound like they belong together, two calm, well-mannered cousins at the same family reunion. Both are polite, non-confrontational words, the kind that sit quietly at the table and don’t argue about politics. However, living them out, day by day, is a much more complex endeavor. When I first entered Alcoholics Anonymous, I thought acceptance was the finish line. I accepted that I was a recovering alcoholic, and I did it with relief, like finally finding the right pair of shoes after years of blisters. I not only participate and continue to be of service in AA, but also enjoy it. Acceptance felt like crossing over into a new life. I had faced the truth about myself, and the truth and I were shaking hands.

But then came allowance, a sneakier, more personal challenge. It’s one thing to accept that I am in recovery; it’s another to allow myself to be where I am in that recovery on any given day. Some days I’m glowing with gratitude, and other days I’d rather snap at the microwave for taking too long to heat my coffee. Allowance is about letting those human fluctuations happen without judgment. It’s about saying, “Okay, self, today we’re a little tired and cranky, but that’s not the end of the world,” rather than, “Pull yourself together, you should know better by now.”

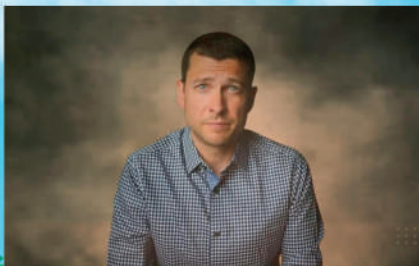
The same is true with MOGAD, my rare and incurable disease. Acceptance was the first mountain to climb, understanding that this condition is now part of my life story, without bargaining for a different ending. But allowance comes in daily, bite-sized portions. It’s one thing to accept that I have MOGAD; it’s another to allow myself the grace to live today with whatever version of symptoms or energy levels I wake up with. Some mornings I’m ready to take on the world. Other mornings, I take on a second cup of coffee and a gentle reminder that pajamas can be a legitimate outfit.

I’ve realized that acceptance and allowance are partners, but not identical twins. Acceptance is the solid decision, the overarching “yes” to reality. Allowance is the living, breathing flexibility that follows, the willingness to honor the ebbs and flows without seeing them as failure. Acceptance says, “This is my truth.” Allowance says, “And this is how that truth looks today.” The happy compromise? I think it lies in grace—God’s grace, specifically, because it doesn’t keep a daily performance chart. Grace tells me that I don’t have to pretend to be stronger than I am, nor do I have to apologize for the days when I am not strong. Grace lets me be both the woman who walks into AA meetings with confidence and the one who occasionally wonders if her socks match. It allows me to be the patient who can explain Myelin Oligodendrocyte Glycoprotein Antibody-Associated Disease, to a stranger and the patient who needs to take a nap halfway through explaining it.

So, no, this isn’t a sad story. It’s a realistic one, with a dash of humor and a lot of humility. Acceptance may have been my first big victory, but allowance is what lets me keep living with a full heart, even when the coffee is bad, my disease is unpredictable, and my best outfit is still in the laundry. And in the quiet tug-of-war between the two, I’ve decided I don’t need a winner. I need enough Grace to keep showing up.

Secretary Report – May 6, 2025 and June 10, 2025 minutes were approved.

Reports

- ☒ Teri, accountant, presented the June 2025 financial report. Highlights are as follows:
Receipts including sales = \$10,327.38 (includes 7th Tradition contributions in the amount of \$4,283.31);
Total expenses = \$9,603.68; June Net Cash = \$723.70; Cash Available for Operations = \$25,540.79 (plus
\$20,197.99 Operations Prudent Reserve and \$11,000 Literature Prudent Reserve). Inventory on Hand =
\$14,644.01. Please see June 2025 financial report for full details.
- ☒ Intergroup Chair: Ryan P. reported TAC's literature purchase was so large they are using a little of the
store's space until the literature can be distributed. The second annual Lefty's River Float is on August 3rd
beginning at 1:30 pm at Barber Park with a BBQ/potluck at 3:30 pm at the Old Timer's Shelter in Ann
Morrison Park. Thanks to all who helped organize this event.
- ☒ Intergroup Treasurer: Kimmie P. presented Treasurer's report. Beginning balance = \$911.87; one check
issued in the amount of \$140.00 as payment for rent of the picnic shelter in Ann Morrison Park for the
Lefty's River Float and BBQ; ending balance = \$771.87. Savings account balance = \$25.00
- ☒ Intergroup Co-Chair: Richard T. asked if groups would be interested in celebrating National Sobriety Day on
September 14th at Tully Park (2500 N. Linder Rd, Meridian). The park has a nice playground. This would be
an all-day event with potluck/snacks. Intergroup will determine financial support after the Lefty's River
Float. Doug suggested the idea be taken to the groups.
- ☒ Store Report: Jen L. has not received any requests from the store to sign checks. Doug stated he signed the
checks, but many of the payments have been set up on autopay/payment by card. Also, per Doug, Kim
is researching using a different vendor for the sobriety coins due to the quality of the coins provided by the
current vendor. Tony purchased a new cart for the store – has all four wheels intact.

potluck and groups sponsoring the dinner. This is a good activity for the district. Doug is announcing his

business meetings which he is present at. Also, District 4 sponsored their 2nd annual Duck Valley
campout. The Duck Valley group has been "adopted" by District 4. The campout was well attended and

Doug will visit with the Intergroup web servant to ensure all the flyers migrate. Teri will process payroll on her system. The internet speed needs to be increased.
- ☒ Doug contacted Sparklight. Their internet service is faster than CenturyLink. Cost = \$74.99/month with 1-year contract; \$63.44/month with 3-year contract (50 speed), but Sparklight's wifi would not provide a mobile option. Teri recommends 100 speed. Doug also stated T-Mobile offers a 5G hotspot which Central Office can take to Assemblies/Conventions for proper sales functions. He will obtain more info. from T-Mobile. Central Office's phone service through CenturyLink will remain in place.

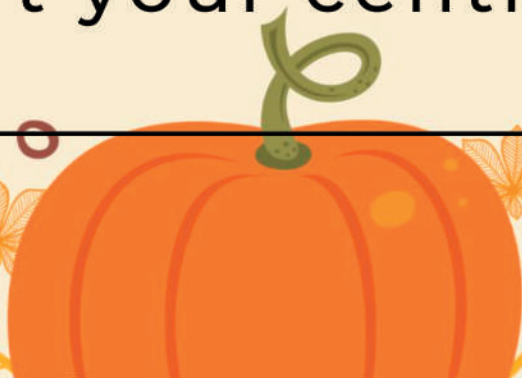
